## 2024 AGM - PROPOSED CHANGE TO CONSTITUTION

## Associate Members

The original concept of creating Associate Members was:
To include volunteers, coaches and umpires who were not otherwise full paying/playing members of the club to be formally registered as part of the club (for insurance and communication purposes amongst other things).
To provide club membership to players who cannot otherwise commit to training and playing regularly the opportunity to join-in with non-league hockey eg Summer hockey, masters, club days.
It was also decided that Associate Members may play in league matches, subject to a limit (currently 6), to help out with numbers when teams were short; however, they could not take precedent over full members.

## Use of Associate Membership Category in League Matches

In recent seasons the category of Associate Membership has been (mis)used with associate members regularly playing in league matches, and not necessarily in the lowest team with the intention to 'make-up numbers'. Associate members have been included in squads even when the number of players available and selected is sufficient (ie in the order of $13,14,15$ players per team); players from lower teams have not been moved up; and/or full members have been denied pitch time.

To forestall this occurring in the future it is proposed to introduce a new membership category and reiterate the intention of the Associate Member; and more clearly define participation in league matches and non-league, 'social' hockey.

## Proposed Membership Categories - 2024/25

Full Member. Pays the full membership fee and can participate in any club activity.
Social Member - New. Pays a nominal membership fee ( $£ 20.00-£ 25.00$ ? ) to cover insurance and club overheads. Is permitted to participate in 'social' hockey (i.e. Masters training, Summer League, B2H, Pay-n-Play etc) but not in senior squad training (Tuesdays/Wednesdays) and league matches (including pre-season friendly matches).

- Any training/match fees for 'social' hockey can then be the same for all members, Full or Social.

Should a Social Member wish to participate in senior league hockey they must join as a Full Member.

Associate Member - Criteria Reaffirmed. Limited to anyone who provides bona-fide volunteer 'services' to the club (i.e. umpiring, coaching, junior manager, photographer etc), but does not participate in playing hockey.

- No membership fee (i.e. free)
- By 'invitation only', at the discretion of the management committee.

Should an Associate Member wish to participate in 'social' hockey they must join as a Social Member.
Should an Associate Member wish to participate in senior league hockey they must join as a Full Member.
